FEATURES AND BENEFITS

WHERE TO USE

For use on all types of carpeting, especially where there is heavy traffic. Recommended for use on colourfast fabrics only. To test for colourfast fabrics, apply in a hidden area. Using a clean white cloth, wipe solution into fabric. If no colour is removed, proceed with cleaning.

HOW TO USE

Apply immediately after the carpet has been cleaned and is still damp. Barricade's formula is ready to use and does not require any dilution. Spray directly on the carpet or upholstery evenly but without saturating the material. Do not overwet carpet or upholstery – a fine mist setting should be used. Work the solution into the carpet immediately after spraying using a pile brush or shag rake. Allow fabric to dry thoroughly.
