HOW TO USE

Additive to cleaning solution: Dilute according to the dilution rates listed below. Add to your cleaning solution, carpet extractor, mop water or hard surface cleaner.

Air freshener: Using a spray bottle, spray upwards into the centre of the room with a slow sweeping motion, paying special attention to odour producing areas.

Recommended dilution rate:

Room deodorizing	1:10
General cleaning	1:80-1:160
Carpet cleaning	1:80-1:160
Recreational vehicle and marine toilet holding tanks	1:160

Note: Adjust rates to suit your needs.
